

**MINISTRY OF TRANSPORT****GENERAL AUTHORITY FOR ALEXANDRIA PORT****Decree No. 2699 for the year 2019**

Issued on 8/12/2019

**Regarding the collection of fee for occupying the waters of the outer anchorage area****Chairman of the Alexandria Port**

Following perusal of General Authorities' Law No.61 for the year 1963;

Law No.6 for the year 1967 regarding the establishment of the General Authority for Alexandria Port;

Law No.53 for the year 1973 regarding the state budget and the general approvals attached thereto;

Law No.8 for the year 1990 regarding the issuance of the Maritime Trade Law;

The Presidential decree No.3293 for the year 1966 setting the purviews and responsibilities of the General Authority for Alexandria Port;

The Presidential Decree No.110 for the year 2000 regarding granting the chairmen of port authorities the administrative supervisory authorities over all department operating inside the ports;

The Presidential Decree No.57 for the year 2002 regulating the Ministry of Transport;

The Decree of the Minister of Transport No.287 for the year 2011 issued on 24/5/2011 regarding the issuance of regulations for the execution of some of the provisions of the vessel' safety law No.232 for the year 1989;

The Decree of the Minister of Transport No.488 for the year 2015 regarding the fees for the services provided to vessels at Egyptian ports, the usage fee of the fixed and floating facilities and constructions of the Port Authorities and the Egyptian Authority for Maritime Safety (EAMS) and the fee for the electronic services provided by the Port Authorities;

**DECIDED:****(Article One)**

Vessels at the outer anchorage area of the Alexandria port shall be dealt with as follows:

**First: General Cargo Vessels:**

- 1- Vessels at the outer anchorage area shall be exempted from payment of the fee for occupying the water for the period starting as of the date of arrival until the end of the fourth day at the outer anchorage area.
- 2- A fee amounting to (USD 0.7 / Linear meters / day) with a maximum limit of (USD 150 / day / vessel) shall be collected until the fifteenth day during the vessel's stay at the outer anchorage area.
- 3- A fee amounting to (USD 1.5 / meter / day) shall be collected starting as of the sixteenth day until the date the vessel departs from the outer anchorage area.

**Second: Grains, strategic commodities and petroleum products' Vessels:**

- 1- Vessels at the outer anchorage area shall be exempted from payment of the fee for occupying the water for the period starting as of the date of arrival until the end of the eighth day at the outer anchorage area.
- 2- A fee amounting to (USD 0.7 / Linear meters / day) with a maximum limit of (USD 150 / vessel / day) shall be collected starting as of the ninth day of arrival until the end of the nineteenth day during the vessel's stay at the outer anchorage area.
- 3- A fee amounting to (USD 1.5 / Linear meter / day) shall be collected starting as of the twentieth day until the date the vessel departs from the outer anchorage area.

**Third: Vessels awaiting instructions:**

- 1- A fee amounting to (USD 5 / Linear meters / day) shall be collected starting as of the date of arrival of a vessel at the outer anchorage area until the third day.
- 2- A fee amounting to (USD 10 / Linear meter / day) shall be collected starting as of the fourth day until the date the vessel departs from the outer anchorage area.

**(Article Two)**

Vessels awaiting instructions shall mean every vessel at the outer anchorage area upon arrival or departure from the port, without the prior notification of the maritime agent, which has not been listed in the plan of vessels entering the ports of Alexandria and Dekheila, for the purpose of berthing alongside the berths or the inner anchorage area.

**(Article Three)**

Collection from Vessels flying the Egyptian flag shall be made in Egyptian pounds.

**(Article Four)**

If a vessel is in the outer anchorage area pursuant to the decision of the port authority or as a result of the occupation of berths (port congestion), the vessel shall be exempted from the stipulated fee.

**(Article Five)**

Vessels loaded with cargo in favor of the General Petroleum Company or the General Authority For Supply Commodities shall be exempted from payment of the stipulated fee in this Decree, that applies to all types of cargoes.

**(Article Six)**

This decree is to be published in the Egyptian Gazette and shall come into force from the next day of its publication.
